General Business

It is proposed that the following points will be discussed and voted on:-

- It is proposed that the NSWRA increases its annual subscription.
 The reasons for the proposed increase are:
 - a) the current rate does not cover production and distribution costs of the newsletter
 - b) we are required to pay the ARA a \$1.00 levy for each financial member of the NSWRA

Checkpoint Markers

Over the past two years, several orienterring clubs in N.S.W. have been kind enough to loan us checkpoint markers for use at rogaines.

While practical support of this nature may be acceptable in the early days of a new sporting group, it is time that we started to become more self-sufficient.

With this idea in mind, we have successfully lobbied the A.R.A. for the provision of a grant to purchase checkpoint markers. The \$250 we have received has put us in a much better position regarding acquisition of equipment. We now have 40 brand new shiny checkpoint markers and punches.

ROLE OF THE ARA

After discussion amongst the state delegates it has been agreed that the ARA can serve a valuable role in promoting contact between the various rogaining bodies and in supporting new ones. To this end we propose to greatly expand the support available from the ARA to members travelling interstate. In particular we make the following proposals:

- That the ARA pay the entry fee for any rogainer who belongs to a member association and who travels interstate to a rogaine. (Where the rogaine is run by a member state which waives entry fees for such competitors, this amount shall be paid directly to the state body.)
- That any rogainer who belongs to a member association and who travels over 2000 kilometres to an event shall receive \$50 from the ARA by way of a travel subsidy.
- iii) That a grant of \$250 be given to the NSWRA to assist in the manufacture or purchase of checkpoint markers.

A.R.A. Business continued

ARA SUBSCRIPTION, 1985

WARA has proposed that the subscription for state associations in 1985 be \$1 for each member.

COMPETITION BETWEEN STATES

It is proposed that there be no formal competition at the 1985 National Championships.

1986 ARA CHAMPIONSHIPS

It is proposed that these be held under the auspices of WARA. The coordinator and date are not known at this stage.
